Re: FY2023-24 Budget & Corporate Plan Timeline

- 1. The Ministry of Finance (MOF) wishes to advise all line ministries, departments and agencies (MDAs) on the *Timeline for the FY2023-24 Budget & Corporate Plan Formulation process* (Annex 1). This is the first of a series of guidance to assist MDAs in the preparation of their budget and planning submissions for financial year 2023/24 2024/25.
- 2. The *Timeline* outlines the key tasks and due dates that the Ministry of Finance will closely follow in order to successfully meet the submission deadline to Parliament, latest by the end of May 2023.
- 3. As such, it is imperative that all MDAs prepare their detailed budget proposals in compliance with the deadlines set out in the Budget and Corporate Plan Timeline; as per Section 11 of the Treasury Instructions 2020

4	End Jan	Issue Budget Circular – which will include budget ceilings for each MDA; budget submission guidelines and templates. Will include climate budget tagging guidelines for 3 pilot MDAs.	
5	1st week Feb	MOF holds CEO Forum, Donor Forum and MDA workshops on the FY2023-24 Budget Strategy and Budget Circular	
6	End Feb	Deadline for all MDA budget and CP submissions to MOF and NP	
7	1st – 2 nd week March	Joint-Review of MDA budget & CP submissions by MOF & NP Joint – Review of MDA staff proposals and structures by MOF & PSC	
8	3 rd week- End March	Hold consultations with MDAs on results of reviewing budget submission
